Now this indenture witnesseth as follows:-

1. The Founder /settler is desirous of creating the Trust in the name and style of "R.K.Trust", for pious/charitable purpose and object as already stated above. The school/schools will also be governed by this trust.
2. The Trustees have also consented to act as trustees without getting any remuneration ,so that the pious mission and charitable obligation of the founder may be fulfilled with better property. In proof of their willingness, they have made their signature/ signatures after reading understanding and knowing the facts mentioned in the contents of this deed.
3. The name and style of the Trust is be " K.K.Trust" at Sonpurwa, Garhwa. This office may be removed or transferred at any other such place or places as the trustees may think fit and proper.
4. In case of any vacancy amongst the

the trustees occasioned by death, resignation, voluntary retirement and incapability the founder will fill up the vacancy and after his death the remaining trustees shall make the appointment according to the decision of the majority of the remaining trustees.

5. In pursuance of the said wish and desire of the founder, the founder do hereby grant, convey, transfer assign and assume to the trustees, ALL THAT PROPERTY described in following schedule AND DELIVER the same hereto duly endorsed in favour of the trustees to HAVE AND TO HOLD THEM all upon trust for the object and wish, all subject to the powers provisions, and agreement hereunder declared and expressed.

6. The Trustee or trustees shall make necessary arrangement to obtain the land for establishment of school/ schools and there after erect, build, construct on the acquired land.

7. The Trustees shall manage and develop the said property and every part

thereof as mentioned in the Schedule hereto and after having paid Government revenue, taxes and all expenses and management shall use the balance of income as well as the income from future securities which the same may hereafter be converted by them for the recurring expenses of the School/Schools any balance remaining after making such expense shall be deposited in the Nationalised Bank and invested in such manner as the trustees may consider proper.

*8. The Trustees shall have power to convert increase and develop the income of Trust so that wish and desire of the founder may be fulfilled but they shall have no power to sell, mortgage, otherwise transfer the property of the Trust, without getting any permission from the founder of the deed or his legal heirs or without getting permission of the District Judge, having jurisdiction over the subject.
